# About the job

The RIG Service Delivery Manager role plays a pivotal role within the Risk, Insights, and Governance (RIG) team, part of our Corporate Services Division. This position supports the Executive Manager, RIG, in owning and driving the successful delivery of assigned business initiatives and enhancing operational effectiveness across the team.

The role involves planning and delivery of key initiatives and workstreams, applying structured and agile approaches to ensure progress, alignment, and timely outcomes. You will help define and track delivery plans, lead cross-functional collaboration, and devise innovations to ensure the continuous improvement of team practices and reporting.

In addition to initiative delivery, the role draws on business analysis and risk management expertise to support and lead the execution and monitoring of assigned team priorities. It also includes coordinating team activities, facilitating internal business unit reporting, and managing the delivery of key external service providers, including our Monitoring & Evaluation and Internal Audit partners. You will have responsibility for the outcomes of these engagements and ensuring they deliver enduring strategic impact.

#### Initiative Planning and Delivery

- Support the Executive Manager, RIG by leading the planning, coordination, and delivery
  of multiple initiatives and projects, ensuring alignment with organisational strategy and
  goals.
- End-to-end ownership of key initiatives including developing business cases, delivery plans, scopes, schedules, budgets, and track the progress of assigned initiatives against key objectives, including core milestones, key performance metrics and benefit realisation.
- Establish project priorities, monitor performance and proactively manage risks, issues, and dependencies.





### **Analysis and Business Unit Reporting**

- Undertake Business Analysis activities to support decision-making, including identifying trends, risks, and performance insights, bringing an "on-the-business" strategic perspective
- Own the preparation of regular RIG team and business unit reporting, ensuring accuracy and alignment with organisational requirements. Oversee and support the progressive development, implementation and effective operation of RIG processes, tools, and templates to support continuous improvement and enhance team performance.

### **Vendor and Contract Management**

- Own the strategic delivery of services from assigned key external providers (e.g. Internal Audit, Monitoring & Evaluation), ensuring outcomes are aligned with RIC's business objectives and informed by its operating context.
- Drive vendor performance and contract execution by ensuring timely access to data, maintaining accountability for deliverables, and managing documentation and milestone tracking to support continuous improvement.

### Stakeholder Engagement

- Build and maintain strong relationships with key stakeholders across the organisation and externally, including government agencies, industry partners, and specialists.
- Facilitate cross-functional collaboration to ensure the successful implementation of risk initiatives.
- Lead regular project reporting and communication to the Executive Leadership Team (ELT), Committees, and other stakeholders.
